### **SHERIFF JOHN SPEARS REPORTS THE FOLLOWING ONGOING ACTIVITIES FOR THE YEAR AND NARRATIVE EXCERPTS FROM THE WEEK ENDING January 9, 2017.**

1/2 Charish Goss, La Farge, was traveling east on State Highway 82, Town of Webster, on a downhill curve. Goss lost control due to ice on the roadway, crossed the centerline, struck a sign, and came to a rest in the ditch. No injuries were reported.

1/3 Twomey Danielson, La Farge, was traveling south on Canyon Avenue, Town of Union, and came around a corner. A township snow plow was backing up on Canyon Avenue, spreading sand on the icy roadway. Danielson tried to avoid the collision, but side swiped the snow plow. No injuries were reported.

1/3 Wisconsin State Trooper Luke Yahn's unmarked police vehicle was parked while he was assisting stalled vehicles on Brinkman Ridge Road, Town of Hamburg. Joseph Garbers, Chaseburg, was slowing down as he approached the stalled vehicles, but because of the icy road conditions, he lost control of his truck and slid into the police vehicle. The impact was at a slow speed so there was only minor damage to both vehicles, and there were no injuries to the parties involved.

1/5 Amy Hofer, La Crosse, was traveling north on South Creek Road, Town of Genoa when she lost control on the ice covered roads, hit an embankment, and overturned. No injuries were sustained at the time of the accident. The vehicle was towed due to disabling damage.

1/5 Abbey Williams, La Farge, was traveling north on County Road D, Town of Clinton, lost control of her vehicle on ice covered roads, left the roadway, and overturned. No injuries occurred. The vehicle was towed.

1/5 Nikki Boggs, DeSoto, was traveling north on Hecks Point Road, Town of Genoa, when she lost control of her vehicle, hit an embankment, and stuck a power pole. No injuries were received.

1/6 Morgan Ness, Viroqua, was traveling eastbound on US Highway 14 turning left onto B and L Lane, Town of Franklin. Jennifer Clark, Hillsboro, was traveling behind, did not see the Ness vehicle and struck it from behind. No injuries occurred. The Clark vehicle was towed due to disabling damage.
