### **SHERIFF JOHN SPEARS REPORTS THE FOLLOWING ONGOING ACTIVITIES FOR THE YEAR AND NARRATIVE EXCERPTS FROM THE WEEK ENDING March 13, 2017.**

3/6 Kevin Trussoni, Viroqua, reported sometime in the past 5-6 days someone threw something through a window at his Town of Jefferson property.

3/6 Charlotte D. Kimball, Hillsboro, was turning left into the County Market parking lot, in the Town of Hillsboro, and failed to yield the right of way to a vehicle driven by Benjamin T. Weber. Both vehicles went out of control and came to rest in the ditch. Neither driver suffered injuries, but both vehicles were towed due to disabling damage.

3/6 Dustin M. Stalsberg, Viroqua, took his eyes off the road on US Highway 14, Town of Coon, his vehicle traveled through a ditch, and struck a rock embankment. The vehicle had to be towed because of disabling damage. Stalsberg was not injured.

3/6 Timothy E. Huffman, Hollandale, was traveling on County Road V, Town of Webster, when he hit a soft shoulder, was sucked into the ditch, and scraped against the embankment. Huffman was not injured and his vehicle suffered minor damage.
