### **SHERIFF JOHN SPEARS REPORTS THE FOLLOWING ONGOING ACTIVITIES FOR THE YEAR AND NARRATIVE EXCERPTS FROM THE WEEK ENDING January 8, 2018.**

01/03 April Rasmussen, DeSoto, was traveling eastbound on State Highway 82 in the Town of Sterling. Rasmussen lost control on the snow covered road, crossed the centerline, left the roadway, and struck an embankment. No injuries were reported.

01/03 Kaila Britton, Kendall, was traveling eastbound on County Road F in the Town of Whitestown. Britton failed to negotiate a curve on the slippery roadway. The vehicle traveled over an embankment and struck a rock. The accident happened on January 2<sup>nd</sup>, but was not reported until the next day.

01/03 Kirstin Miller, Cashton, was traveling eastbound on County Road P in the Town of Clinton. Miller was negotiating a curve and lost control of the vehicle due to the snow covered road. Miller crossed the centerline, went into a ditch, and struck several small trees. Miller received possible injuries, but was not transported to the hospital at the time of the crash.

01/03 Nichelle Skrupky-Nelson, Viroqua, was traveling eastbound on US Highway 14 in the Town of Coon. A deer collided with the vehicle on the passenger side. Skrupky-Nelson reported injuries, was evaluated by EMS at the scene, and was taken to the hospital by a private vehicle.

01/05 Havin Rehwinkel, Holmen, was traveling westbound on County Road P in the Town of Clinton, when the vehicle's front passenger side tire broke disabling the vehicle's travel. No injuries occurred.
