SHERIFF JOHN SPEARS REPORTS THE FOLLOWING ONGOING ACTIVITIES FOR THE YEAR AND NARRATIVE EXCERPTS FROM THE WEEK ENDING June 18, 2018.

06/11 Billy Rogers, Mundelein, IL, was operating his motorcycle on County Road P, Town of Coon. Rogers was traveling with a group of riders, negotiated a curve, and missed the turn. His motorcycle went off the roadway into the ditch. Rogers sustained possible injuries and was transported by EMS to Gundersen Health System.

06/14 Roger Mellum, Prairie du Chien, was traveling northbound on Irish Ridge Road, Town of Clinton. A horse and buggy was traveling southbound across the road, when the driver lost control of the horse, and struck the Mellum vehicle. No injuries were reported. The horse was also okay.

06/15 Andrew Grant, Coon Valley, was traveling eastbound on US Highway 14, Town of Christiana, and struck a deer. After the deer was struck, it continued across the road, when the westbound vehicle, driven by Jill Manning, Westby, struck the deer. Grant reported no injuries. Manning reported a possible injury, but was not transported to the hospital at the time of the accident.

06/16 Erik Luebke, Westby, was stopped at a stop sign on Saugstad Road at the intersection of State Highway 27 / County Road P, Town of Christiana. Luebke did not see the northbound vehicle traveling on State Highway 27. The northbound vehicle, driven by Ivan Joholski, Viola, swerved into the ditch/field to avoid the collision. Joholski traveled over a curb. The Luebke vehicle came to rest facing northbound on State Highway 27. No injuries were reported at the time of the crash.
